## 2026 ILLINOIS CRIMINAL OFFENSE GUIDE (IGOG)

Our **2026 ILLINOIS CRIMINAL OFFENSE GUIDE (ICOG)** will be available soon.

The **2026 ICOG** consists of three parts. **PART ONE**, found in Sections A through O in Volume One, of our two-volume set, is the **Criminal Charging Guide**. The **Charging Guide** (the Old **Uniform Complaint Book**) lists the elements of all of the major offenses in Illinois in the language used by Prosecutors who charge those offenses. Law Enforcement officers will find this guide to be a valuable tool that will assist them in recognizing criminal offenses and writing offense reports. **PART TWO**, found in Section T in Volume Two, is the **Criminal Sentencing Guide**. It provides all of the potential sentencing alternatives for all of the offenses found in the **Charging Guide** in one place. Rather than having to look in a half/dozen different places to determine what potential sentences are available, you are able to find that information in only one place. **PART THREE**, found in Sections W and X in Volume Two, is the **Criminal Offense Digest**. It lists every criminal offense found in the Illinois Compiled Statutes by Chapter, Act, and Section. This Digest gives you the citation of every offense, its criminal classification, and the Act or Law in which it is found. Also found in Volume Two, are the various appendixes that are intended to assist you in using this publication.

The **2026 ICOG** is now available in **two formats**:

**FIRST**, an **UNRESTRICTED VERSION** of the **ICOG** is available via a **subscription** on-line on our Website ([www.ipsicog.com](http://www.ipsicog.com)) through the use of a user ID and password which we will supply. The individual files of this version will be **fully word searchable and fully printable**. You will be able to customize your own **ICOG** by printing off the individual complaints that are most often used by your agency, and you will also be able to print off as many copies of as many of those complaints as you desire. In this way, you can create an unlimited number of customized digital or paper versions of the **ICOG** for your Agency and your Officers at one low price. The subscription will run from January thru December 2026.

**SECOND**, you can obtain a **RESTRICTED VERSION** of the **ICOG** sent to you via a Flash Drive. This is also **fully word searchable**, but it is **read-only and cannot be printed**. You can, however, highlight, cut, and paste off of this version. You simply will not be able to print off the individual files. Also, this version of the **2026 ICOG** can be downloaded onto your computer or into your network system for all of your Officers to use.
